Mr Tan is designated Senior Consultant (OSH Specialist) at OSH Division, Ministry of Manpower (MOM), Singapore. In his role, he provides guidance and advice on occupational hygiene (OH) and OH-related matters. He helps to build competencies of OH professionals in their OH practice. He represents MOM in technical committees to help raise WSH standards and make Singapore a country renowned for best practices in WSH.

In his previous role as Deputy Director of MOM OSH Specialist Department, he spearheaded the development of polices and strategies in the areas of standards, regulations, enforcement, research and best practices related to OH. He directed the development and implementation of OH Intervention Programmes to manage workplace health hazards and to safeguard persons against such hazards. He initiated



and developed various OH training courses to raise industry capabilities in managing workplace health hazards.

An industrial hygienist by profession, Mr. Tan has been practising comprehensive OH since 1977, focusing on regulatory IH which includes workplace risk assessments, inspections, investigations and auditing. He has written and co-authored numerous articles, technical reports, guidelines, advisories and more than 30 papers on OH.

Currently, he is serving the Singapore Registered Industrial Hygienists Board of the Singapore Occupational and Environmental Health Society as its Vice-chairperson. He also leads the MOM WSH Risk Management Task Force in developing the risk management framework. He was the previous co-chair of the national GHS Task Force responsible for coordinating the implementation of hazard communication system. He is the present co-convenor for CP 99 Workgroup responsible for reviewing Singapore Standard (SS) on Industrial Noise Control and also co-convenor for SS LEV Workgroup responsible for developing the Singapore Standard on Design, Operation, Maintenance and Testing of Local Exhaust Ventilation Systems (LEV).

An Adjunct Associate Professor at the National University of Singapore, Mr. Tan holds a B.Sc. (1st-Class Honors) in Physics from the University of Singapore, a M.Sc. in Health Physics from the University of Rochester and a M.Sc. in Industrial Hygiene from the University of Pittsburgh. He was awarded the William Yang Award from the American Industrial Hygiene Association in 2012 for his outstanding contributions in industrial hygiene.

## Synopsis:

Risk management (RM) is the cornerstone of safety and health management. The objective of WSH RM is to eliminate or mitigate risks so as to prevent accidents, injuries and ill health at workplace. Introduced in 2005 when Singapore started to reform its WSH system, the WSH RM framework has helped to shape the WSH landscape in Singapore with a significant reduction of accident fatality rate over the last decade. This presentation covers the journey of RM development, the multiple-prolonged strategies to drive RM including legislation and enforcement, the challenges faced in RM implementation and the approaches to enhance WSH RM. It also discusses risk assessment methodology focusing on risk assessment for health hazards such as noise, chemicals, bio-organisms, heat stressor and ergonomics factors.





In addition, it presents the occupational hygiene development and OH professionals registration scheme in Singapore.
