"The latest revision of the "Code of Practice for Safety and Health at Work in Confined Spaces" has been effective since 30 November 2024." However, based on the past experience, gassing incidents, such as "hydrogen sulphide" poisoning, are among the most common serious accidents. In view of the hazards, to raise awareness on the importance of appropriate environmental air monitoring methods and the use of suitable personal protective equipment, OSHC and the HKIOEH decide to hold an **online open seminar** on 26 March 2025.
